#### VENDOR INFORMATION / GUIDELINES

Show hours are Saturday from 12:00 to 5:00. Set up from 10am – 11:30am. If you need longer set up time please contact the Vendor Coordinator. All vendors are expected to be set up and open for business during the Show hours of operation – please, no late arrivals and no early tear-down activities. Your cooperation is much appreciated.

1. The application fee is \$20 per space
2. The Show Committee reserves the right to refuse any applicant due to limited space or undesirable and/or dangerous products or behavior.
3. FIRST PAID, FIRST SERVED – we are happy to accept payments for the following year's show now. **The show will be held rain or shine. NO REFUNDS.**
4. If electricity is used, EXTENTION CORDS ARE THE RESPONSIBILITY OF THE VENDOR.
5. Vendor's space is approximately ten (10) feet by ten (10) feet. Tents (weighted down) and tables provided by the vendor are allow in the spaces.
6. **No vendor may sell FOOD** for consumption on Fair Grounds (packaged food OK (e.g., jams, honey, eggs), vendor responsible for obtaining any required licensing/permits).
7. Vendor vehicle may be parked near the space during setup, but must be moved to grassed parking area before show start (unless vendor vehicle is part of vendor display in an outside space).
8. Vendors are required to keep and to leave the plot clean. Vendors may use the trash receptacles provided.
9. **All raffles, to include any sponsored by individual vendors or other groups, that are held on Show grounds are to solely benefit the charities identified by the show organizers for this year's show.**
10. Vendors are not to sell spray string, firearms of any sort, sharp-edged knives (pocket, hunting, daggers, etc.) or fireworks of any variety. This is a family friendly charitable event, please keep this in mind in your display design.
11. Paid vendors will be notified via email of space assignment prior to the event. A non-transferable vendor permit will be issued to each paid vendor. This permit must be with the vendor stand when open for business during the Show.
